## 1. Call to Order

#### 2. Certification of Notice of Meeting – *Lisa Kam*

Kam read the Certification of Notice of Meeting

I, Lisa Kam, Interim Assistant Secretary to Walnut Creek Mutual Seventy, certify that a Call for Candidates notice was published in the Rossmoor newspaper on March 6, 2024.

There are two open Director seats on the Board to be filled at this year's election. Election ballots will be counted during this Annual Members Meeting and the winning candidates will be annualed and then seated at the Board of Directors Organizational Meeting.

In accordance with Corporations Code §7511(b), a notice of the Annual Members Meeting was mailed to the membership on June 18, 2024.

Inspector of Elections announced the receipt of ballots for the 2024 Election of Directors and informed members that she will be counting the ballots during the Annual Members Meeting. The Inspector of Elections received 81 ballots. 7 ballots were invalid because members did not sign the envelope. Therefore, the quorum of ballots is 74 valid.

The agenda was amended to move the topic of Special Assessment to the top of the agenda. No motion was made for the amendment.

## 3. Special Assessment

- a. Presentation on Deck and Termite Repair Work Lichtenstein and Cheung presented the report.
  - There has been significant dry rot and termite damage throughout the Mutual. A special assessment to pay for repairs in the amount of \$15,332 per manor, was approved at the May Board meeting. The special assessment can be split into two payments with the first payment in the amount of \$7,666 due August 1, 2024, and the second in the amount of \$7,666 due August 1, 2025. Work will be completed by December 2026.
  - 2024 coupon is \$1,643 showing an increase of 19.8% from 2023 coupon at \$1,372.
