GOLF ADVISORY COMMITTEE REPORT

REGULAR MEETING FRIDAY, February 14, 2020, AT 9:05 AM

A regular meeting of the Golf Advisory Committee (GAC) was convened by the Chairman, John McDonnell, at 9:05 a.m. on Friday, February 14, 2020, in the Board Room at Gateway Complex.

Present, in addition to the Chairman, were William L. Herrick, Vice Chair, Sara Buehrer, Carol Dull, Mary Hufford, Michael D. Wener, Michael Weisenberg, and Kenneth Anderson, ex-officio member and GRF Board representative. Also attending were Timothy O'Keefe, CEO, Mark K. Heptig, Director of Golf, GRF; and Dickey Nitta, Chief Golf Course Marshal.

Attendance

There being no corrections, the report of the regular meeting of the Committee held on January 10, 2020, was approved, as written, by unanimous consent.

Report Approved

The Chairman explained the importance of the water reclamation plan and invited Mr. O'Keefe to comment.

Chairman's Report

There was no correspondence or announcements.

Mr. Anderson, representing the GRF Board, had nothing to report.

Ms. Hufford, representing the Women's 18-Hole Club, had nothing to report.

Ms. Buehrer, representing the Women's 9-Hole Club, reported that the Rossmoor Niners currently has 150 members and 2 social members. The first General Meeting of the year will be held on Thursday, February 27. Regular Thursday league play will begin on March 12. She thanked golf personnel for putting up a sign on the Creekside #7 hole warning pedestrians to be aware of players teeing off.

Mr. Weisenberg, representing the Rossmoor Men's Golf Club (RMGC), reported that the Club currently has 311 members. A total of 96 members attended the Club's Spring Meeting on the evening of February 10. At the meeting, Club President Brent Atkins gave a presentation about the workings of the Men's Golf Club and introduced members who joined since last year. Members have passed an amendment to the RGMC Bylaws allowing resident-sponsored guests to play in regular weekly events, excluding trophy tournaments.

JUSTIFICATION FOR WATER RECLAMATION

Direct Benefits for Residents:

- GOLF: The original developer created Rossmoor as a golf course community because he believed that golf represented the epitome of a relaxed, retired lifestyle. Water reclamation would keep the golf courses green so that the thousands of golfers in Rossmoor each year can continue to enjoy the game even during drought years. If the golf courses were to die from lack of irrigation, GRF will not have the millions of dollars necessary to rebuild the golf courses without large special assessments, likely in excess of \$1,000 per manor. Even if the funds were available, a rebuilt golf course is only good until the next drought.
- PARK: The golf courses are park-like. They are tranquil, quiet and serene. Hundreds of walkers enjoy the golf course as a park in the evenings and on most Mondays. They also host numerous species of birds including raptors and owls, raccoons, rabbits, and foxes, to name just a few of the favorites, as well as a few we are not quite as enamored with like coyotes, gophers, pigs, turkeys and Canada geese—all of which contribute to the natural beauty of the valley.
- EQUITY: Thousands of homes in Rossmoor have a view of or border the golf courses. Green golf courses preserve home equity value if properly maintained. Dead golf courses reduce home equity value if courses die. In addition, bankrupt golf courses around the country often result in expensive litigation due to the loss of home equity value due to dead golf courses or the transition of golf courses to housing over the objection of residents. The equity in every home in Rossmoor—including those nowhere near the golf courses—benefits from having 6 million square feet of park-like green space running down the middle of the valley as the golf courses are core to Rossmoor's identity.

Benefits for the Community:

These may be even more important than the items noted above!

- ENVIRONMENTAL: In California, water is increasingly viewed as a scarce resource rather
 than the abundant commodity we have been accustomed to for most of our lives. Water
 reclamation provides a sustainable source of irrigation water for the golf courses by
 redirecting tens of millions of gallons of potable water annually to more suitable uses than
 irrigation across the water district's territory.
- FIRE SAFETY: The devastating fires throughout the state in recent years have elevated everyone's concern about fire and evacuations. In the last two years, probably no issue has generated more feedback and comment from the Rossmoor community. Water reclamation would ensure that the golf courses remain green, even during a drought, and provide a critical fire break for the valley. Green grass embedded in irrigated moist soil does not burn.
- EMERGENCY: An irrigated green golf course allows the golf courses to be used as staging areas for emergency personnel and equipment during a disaster and allows the golf courses to be used as evacuation triage during a disaster.
